

A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPAL LOCAL GOVERNMENT UNIT OF TARRAGONA, DAVAO ORIENTAL, REPRESENTED BY ITS MUNICIPAL MAYOR, HONORABLE SAMUEL L. UY, RELATIVE TO THE UTILIZATION OF BALAY SILANGAN INTENDED FOR DRUG DEPENDENT PATIENTS, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH THE LAW.

WHEREAS, presented for consideration before the August Body is a request of the Honorable Governor Niño Sotero L. Uy, Jr., thru his letter, dated September 29, 2023, requesting for the passage of a resolution authorizing him for the abovementioned subject matter, docketed as Communication No. 17-642-2023;

WHEREAS, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states that the Provincial Governor, as the chief executive of the provincial government, shall "represent the province in all its business transactions and sign in its

UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPAL LOCAL GOVERNMENT UNIT OF TARRAGONA, DAVAO ORIENTAL, REPRESENTED BY ITS MUNICIPAL MAYOR, HONORABLE SAMUEL L. UY, RELATIVE TO THE UTILIZATION OF BALAY SILANGAN INTENDED FOR DRUG DEPENDENT PATIENTS, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH THE LAW;
