UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPAL LOCAL GOVERNMENT UNIT OF TARRAGONA, DAVAO ORIENTAL, REPRESENTED BY ITS MUNICIPAL MAYOR, HONORABLE SAMUEL L. UY, RELATIVE TO THE UTILIZATION OF BALAY SILANGAN INTENDED FOR DRUG DEPENDENT PATIENTS, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH THE LAW.

WHEREAS, presented for consideration before the August Body is a request of the Honorable Governor Niño Sotero L. 


