A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A DEED OF DONATION FOR THE PARCELS OF LAND CONTAINING A TOTAL AREA OF ONE THOUSAND FIVE HUNDRED FIFTY-EIGHT (1,558) SQUARE METERS TO THE CITY GOVERNMENT OF MATI, LOCATED AT BARANGAY DAHICAN, CITY OF MATI, PROVINCE OF DAVAO ORIENTAL.

WHEREAS, the Honorable Governor Niño Sotero L. Uy, Jr., has requested this August Body for the passage of a resolution for the aforementioned subject matter;




