A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 311-17-2023 OF THE SANGGUNIANG BAYAN OF SAN ISIDRO, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE ENHANCING THE DELIVERY OF INTEGRATED MENTAL HEALTH SERVICES, PROMOTING AND PROTECTING THE RIGHTS OF PERSONS WITH MENTAL HEALTH CONDITION, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES," CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.

WHEREAS, in his letter, dated October 5, 2023, Mr. Melvin B. Lubitaña, Secretary to the Sangguniang Bayan of San Isidro, Davao Oriental, submitted Municipal Ordinance No. 311-17-2023, for legislative review of the Sangguniang Panlalawigan;

WHEREAS, Municipal Ordinance No. 311-17-2023, or known as "Community Based Mental Health Programs of San Isidro, was enacted on September 19, 2023, during the 60th Regular Session of the 17th Sangguniang Bayan of San Isidro;

WHEREAS, the Municipality of San Isidro, has the responsibility to uphold the right of the people to mental health and encourage mental health consciousness among youth through adopting an integrated and comprehensive approach to the development of its Mental Health Care Delivery System;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Rotchie M. Ravelo, Harold A. Montes, Stephen Paul L. Uy, Daud V. Linsag, and Marietta D. Palmera, it was
