WHEREAS, Municipal Ordinance No. 15-09-09-2023 was enacted during the 48th Regular Session of the 15th Sangguniang Bayan of Boston, Davao Oriental on September 25, 2023;

WHEREAS, the said municipal ordinance also known as the “Granting of Benefits and Privileges to Child Development Workers’ Ordinance, was passed to

promote, provide benefits and improve the total well-being of the Child Development Workers (CDWs) of the Municipality of Boston;

WHEREAS, in her letter dated October 9, 2023, Ms. Mary Gold B. Castres-Petor, Secretary to the Sangguniang Bayan of Boston, Davao Oriental, submitted the abovementioned Municipal Ordinance for legislative review of the Sangguniang Panlalawigan, docketed as Communication No. 17-661-2023;


