WHEREAS, on the 17th day of August 2022, the 17th Sangguniang Panlalawigan of this Province further enacted Resolution No. 17-59-08-2022, entitled: **“A RESOLUTION ADOPTING THE LOCAL INVENTORY OF CULTURAL PROPERTY IN THE PROVINCE OF DAVAO ORIENTAL”**;


