A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2023-15 OF THE SANGGUNIANG BAYAN OF BANAYBANAY, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE REQUIRING POOL/RESORT OWNERS ENGAGED IN THAT BUSINESS AND SIMILAR BUSINESSES TO PROVIDE DULY CERTIFIED LIFEGUARDS AND LIFEGUARDING EQUIPMENT IN THEIR OPERATION, PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES”, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, Pursuant to Section 16 of the Local Government Code of 1991 states that: “Every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which essential to the promotion of the general welfare xxx;

WHEREAS, presented for review before the August body is Municipal Ordinance No. 2023-15, forwarded by Mr. Eden Celestino S. Cacho, Sangguniang Bayan Secretary of Banaybanay, Davao Oriental, docketed as Communication No. 17-690-2023;



WHEREAS, the Sangguniang Bayan of Banaybanay enacted the aforementioned Ordinance on the 12th day of September 2023, in adherence to the mandate provided in Section 16 of Republic Act 7160 which empowers the Local Government Unit, to promote the general welfare of its constituents especially on health and safety among others; thus requiring pool/resort owners to provide lifeguards and lifeguarding equipment fall within this category;


