A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 03, SERIES OF 2023, OF THE SANGGUNIANG BAYAN OF TARRAGONA, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE UPDATING THE TRAFFIC MANAGEMENT CODE OF THE MUNICIPALITY OF TARRAGONA, DAVAO ORIENTAL”, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, Section 16 of the Local Government Code of 1991, provides that “Every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare xxx;

WHEREAS, the Secretary to the Sangguniang Bayan of Tarragona, Ms. Irene D. Tinong, in her letter, dated September 27, 2023, forwarded Municipal Ordinance 03, series of 2023, for an appropriate action of the August Body, the same was docketed as Communication No. 17-639-2023;

WHEREAS, the aforementioned ordinance was enacted by the Sangguniang Bayan of Tarragona, Davao Oriental, on the 25th day of September 2023, to ensure road safety through the observance of ethical driving standards and sound traffic management, pursuant to the constitutional principle that recognizes the protection of life and property and the promotion of the general welfare among others;

WHEREFORE, on motion of SP Member Daud V. Linsag, duly and jointly seconded by SP Members Harold A. Montes, Rotchie M. Ravelo, Stephen Paul L. Uy, and Marietta D. Palmera, it was


