**A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ALLOW THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT KAPIT BISIG LABAN SA KAHIRAPAN – COMPREHENSIVE AND INTEGRATED DELIVERY OF SOCIAL SERVICES, NATIONAL COMMUNITY DRIVEN DEVELOPMENT PROGRAM – ADDITIONAL FINANCING (KC NCDDP-AF) TO UTILIZE THE 65 LINEAR-METER LOT, LOCATED AT BARANGAY TUBAON, MUNICIPALITY OF TARRAGONA, THIS PROVINCE, AS THE PROJECT SITE FOR THE CONCRETING OF COMMUNITY ACCESS ROAD IN THE BARANGAY.**




