**A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 573, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE AMENDING SECTION VI, NUMBER 13 OF CITY ORDINANCE NO. 491, SERIES OF 2022, KNOWN AS “AN ORDINANCE INSTITUTING THE PROMOTION OF HALAL INDUSTRY DEVELOPMENT PROGRAM OF THE CITY OF MATI, CREATING A LOCAL HALAL COUNCIL, APPROPRIATING FUNDS THEREOF, AND FOR OTHER PURPOSES”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD PURSUANT TO ARTICLE III, SECTION 458(a)(1) OF REPUBLIC ACT 7160.**




