A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 95, SERIES OF 2023, OF THE MUNICIPALITY OF BOSTON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY.

WHEREAS, Appropriation Ordinance No. 95, series of 2023, of the Municipality of Boston, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 02, involving an appropriation of <u>ELEVEN MILLION SEVEN HUNDRED EIGHTY-ONE THOUSAND FORTY-EIGHT PESOS (₱11,781,048.00)</u>, was submitted to this Sanggunian for review on August 17, 2023, pursuant to the provisions of Republic Act No. 7160;

**RESOLVED FURTHER**, to inform the Municipality of Boston, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY,** to send a copy of this Resolution to the Sangguniang Bayan of Boston, Davao Oriental, through the Municipal Mayor.
