UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO SIGN AN AFFIDAVIT OF UNDERTAKING (EXTENSION OF PERIOD OF COMPLIANCE) IN RELATION TO THE FINDINGS OF NON COMPLIANCE FROM THE BUREAU OF FIRE PROTECTION – GOVERNOR GENEROSO TO THE DAVAO ORIENTAL PROVINCIAL HOSPITAL – GOVERNOR GENEROSO.

WHEREAS, the Honorable Governor Niño Sotero L. Uy, Jr., in his letter, dated September 13, 2023, requested this august body for the passage of the abovementioned resolution;

WHEREAS, DOPH-Governor Generoso was found to be non-compliant with the necessary fire safety measures in reference to After Inspection Report and Inspection Order No. R11-2023-09-297, dated September 8, 2023. Consequently, the Provincial Government was required by the BFP to install/construct Water Pump for Fire System and was only given 15 days to address the said deficiency;

WHEREAS, in compliance thereof, the DOPH-Governor Generoso had initiated the canvassing of the materials needed and entered into a contract with another six (6) months from September 23, 2023 to March 23, 2024, for the installation/construction of the same;

WHEREAS, due to the complexity of the fire safety requirements and the necessary works to be done, the desired compliance cannot be completed within the prescribed period of time;

WHEREAS, the DOPH-Governor Generoso needs ample time to fully abide with the said requirements pursuant to RA 9514 or the Revised Fire Code of the Philippines and its IRR;


