**A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF CITY ORDINANCE NO. 571, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE ESTABLISHING GUIDELINES, STANDARDS, RULES AND REGULATIONS AND PRESCRIBING FEES FOR THE MANAGEMENT AND OPERATION OF THE LIGHTED PROMOTIONAL SIGNAGES AT CITY GOVERNMENT-OWNED FACILITIES, ESTABLISHMENTS AND PROPERTIES”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD PURSUANT TO ARTICLE III, SECTION 458(a)(1) OF REPUBLIC ACT 7160.**

**WHEREAS**, in his letter, dated September 18, 2023, Mr. Juvy L. Mabini, J.D., Secretary to the Sangguniang Panlungsod of Mati, Davao Oriental, submitted City Ordinance No. 571, series of 2023, for legislative review of the Sangguniang Panlalawigan;

**WHEREAS**, City Ordinance No. 571, series of 2023, was enacted by the 7<sup>th</sup> Sangguniang Panlungsod of the City of Mati, on its 36<sup>th</sup> Regular Session held last September 5, 2023, and was signed and approved by the Honorable Mayor Michelle Marie Denise N. Rabat;

**WHEREAS**, the said ordinance, known as “Lighted Promotional Signages Ordinance of the City of Mati”, was enacted to exercise the power of the City Government of Mati in creating its own source of revenue and to levy taxes, fees and charges as stipulated in Section 129 of the Local Government Code of 1991 or RA 7160;

**WHEREFORE**, on motion of SP Member Joselito B. Villademosa, duly and jointly seconded by SP Members Anna Cheryl N. Castro, Stephen Paul L. Uy, Harold A. Montes, Marietta D. Palmera, Andy A. Monday, Daud V. Linsag, and Rotchie M. Ravelo, it was


