UY JR., THE HEREIN REQUESTS TO AUTHORIZE HIM, FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, RELATIVE TO THE ACTIVITIES WITHIN THE GOVERNMENT CENTER, BARANGAY DAHICAN, CITY OF MATI, THIS PROVINCE, IN RELATION TO EXECUTIVE ORDER NO. 15, SERIES OF 2023, FOR WHATEVER ACTION DEEMED APPROPRIATE THEREOF.

WHEREAS, COMMUNICATION NO. 17- 628- 2023 - A letter from the Honorable Governor Niño Sotero L. Uy, Jr., dated September 21, 2023, addressed to the Honorable Members thru Vice Governor Nelson R. Dayanghirang, Jr., respectfully requesting the Honorable Members of this August Body to pass a resolution authorizing him, for and in behalf of the Provincial Government of Davao Oriental, to donate a parcel of land to the Bureau of the Treasury, represented by Ms. Sharon P. Almanza, through Deed of Donation, located at the Government Center, Barangay Dahican, City of Mati, Davao Oriental;

WHEREAS, COMMUNICATION NO. 17-645-2023 - A letter from the Honorable Governor Niño Sotero L. Uy, Jr., dated October 2, 2023, addressed to the Honorable

Members thru Vice Governor Nelson R. Dayanghirang, Jr., respectfully requesting the Honorable Members of this August Body to pass a resolution amending Resolution No. 17-192-11-2022, duly approved by former Governor Corazon N. Malanyaon, from 520 square meters to 130 square meters to the Bureau of Fire Protection, Davao Oriental;

WHEREAS, COMMUNICATION NO. 17-673-2023 - A letter from the Honorable Governor Niño Sotero L. Uy, Jr. dated October 13, 2023 addressed to the Honorable Members thru Vice Governor Nelson R. Dayanghirang Jr., respectfully requesting to pass a resolution authorizing him, for and in behalf of Provincial Government of Davao Oriental, to represent in the Subdivision Survey of TCT No. 143-2023000860, Provincial Government of Davao Oriental, for government purposes/offices;

WHEREAS, Executive Order No. 15, series of 2023, "Creating a Development Management and Coordinating Committee on the Provincial Government property in Barangay Dahican, City of Mati" issued by the late Governor Corazon N. Malanyaon, on April 11, 2023, Section 5. thereof states, that: "Effective immediately, there shall be a "MORATORIUM" on the approval of requests and proposals previously received/accepted re lot appointment or land development works in relation to the implementation of infrastructure project, as well as, the submission/tender of new requests and proposals of similar nature, involving available portions/parts of the Government Center area."

WHEREAS, in view of the said Executive Order No. 15, series of 2023, this august body finds the need to return the aforementioned requests of the Honorable Governor, for whatever action deemed appropriate thereon;


