

A RESOLUTION DECLARING THE PROVINCIAL CAPITOL OLD MANSION LOCATED AT THE CAPITOL HILL, BARANGAY CENTRAL, CITY OF MATI, DAVAO ORIENTAL AS A SIGNIFICANT CULTURAL PROPERTY OF DAVAO ORIENTAL.

WHEREAS, Section 2 of the Republic Act No. 10066, otherwise known as "National Cultural Heritage Act of 2009", mandates the protection, preservation, conservation, and promotion of the nation's cultural heritage, its property and the ethnicity of local communities;

WHEREAS, Section 14 (b) of the National Cultural heritage Act of 2009 requires local government units to establish and maintain local property registry;

WHEREAS, Article XIV of the 1987 Philippine Constitution declares that the State shall foster the preservation, enrichment and dynamic evolution of a Filipino culture;

WHEREAS, the Joint Memorandum Circular No. 2018-01 issued by the Department of Interior and Local Government with the National Commission for Culture and the Arts mandates the requiring of local inventory of cultural property;

WHEREAS, cultural property refers to all products of human creativity by which a people and a nation reveal their identity whether public or privately-owned, movable or immovable, and tangible or intangible;

WHEREAS, "Tangible Cultural Heritage" refers to physical artifacts produced, maintained and transmitted intergenerationally in a society:

WHEREAS, it includes artistic creations, built heritage such as buildings and monuments, and other physical or tangible products of human creativity that are invested with cultural significant in a society;

WHEREAS, in furtherance to the above cited provisions and for the protection. conservation and promotion of the Oriental Dabawenyo's identity, the Provincial Government of Davao Oriental has declared the PROVINCIAL CAPITOL OLD MANSION (immovable property) as Cultural Property of Davao Oriental and recognizing its significance in the cultural identity of this province;

WHEREFORE, on motion of SP Member Harold A. Montes, duly seconded by SP Member Rotchie M. Ravelo, Anna Cheryl N. Castro, Andy A. Monday, Eleuterio C. Manaytay, and Art Benjie C. Bulaong, it was
