ANNABELLE P. YUMANG, MCH, CESO III; AND THE DAVAO ORIENTAL PROVINCIAL MEDICAL CENTER, REPRESENTED BY ITS CHIEF OF HOSPITAL, DR. REDEN V. BERSALDO, MHcA, RELATIVE TO THE TRANSFER OF FUNDS AMOUNTING TO P6,000.000.00 UNDER THE DOH MEDICAL ASSISTANCE TO INDIGENT PATIENTS (MAIP) PROGRAM.




