A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 04-17-2023 OF THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 04-17-2023 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 04, involving an appropriation of **ONE MILLION SIX HUNDRED EIGHT THOUSAND EIGHT HUNDRED PESOS (P1,608,800.00)**, was submitted to this Sanggunian for review on September 20, 2023, pursuant to the provisions of Republic Act No. 7160;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 04-17-2023 of the Municipality of San Isidro, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the condition that the LGU shall record their financial transactions in accordance with the Revised Chart of Accounts for LGUs effective January 1, 2015, pursuant to COA Circular No. 2015-009, dated December 1, 2015;

MOREOVER, the LGU is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under the Local Budget Circular No. 112, dated June 10, 2016, which requires that *“Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review.”*

RESOLVED FURTHER, to inform the Municipality of San Isidro, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of San Isidro, Davao Oriental, through the Municipal Mayor.
