A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 07, SERIES OF 2023, OF THE MUNICIPALITY OF BAGANGA, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 07, series of 2023, of the Municipality of Baganga, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 01, involving an appropriation of THIRTY-FOUR MILLION EIGHTEEN THOUSAND SIX HUNDRED FIFTY-THREE PESOS & 76/100 (₱34,018,653.76), was submitted to this Sanggunian for review on September 22, 2023, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations:

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Stephen Paul L. Uy, Anna Cheryl N. Castro, Shella Marie S. Go, and Daud V. Linsag, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 07, series of 2023, of the Municipality of Baganga, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- 1. That the creation of position, Local Revenue Officer IV under the Office of the Municipal Treasurer, shall be in accordance with the Civil Service Commission Memorandum Circular No. 12, series of 2022, dated November 8, 2022;
- 2. That the funds appropriated for PPAs in this budget shall be in accordance with the approved CY 2023 Supplemental Annual Investment Program (SAIP)/Development Plan pursuant to Sections 287 and 305(i) of RA 7160; DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2016, dated November 18, 2016; and DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017.

MOREOVER, the LGU is reminded to indicate the Date of Approval of the Appropriation Ordinance by the Local Chief Executive, the same being vital in determining the date of which is required pursuant to the provisions under the Budget Operation Manual for Local Government Units issued under the Local Budget Circular No. 152, dated August 2, 2023, which provides that within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review.

RESOLVED FURTHER, to inform the Municipality of Baganga, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Baganga, Davao Oriental, through the Municipal Mayor.
