**A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 2023-12 OF THE SANGGUNIANG BAYAN OF BANAYBANAY, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE ADOPTING REPUBLIC ACT NO. 10389, “INSTITUTIONALIZING RECOGNIZANCE AS A MODE OF GRANTING THE RELEASE OF AN INDIGENT PERSON IN CUSTODY AS AN ACCUSED IN A CRIMINAL CASE AND FOR OTHER PURPOSES,” AND LOCALIZING ITS IMPLEMENTATION IN THE MUNICIPALITY OF BANAYBANAY”, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.**

**WHEREAS,** the Sangguniang Bayan of Banaybanay submitted Municipal Ordinance No. 2023-12 to the Sangguniang Panlalawigan for an appropriate legislative action;

**WHEREAS,** the said Municipal Ordinance was passed and approved by the Sangguniang Bayan of Banaybanay on its 53<sup>rd</sup> Regular Session on August 15, 2023.



The Ordinance which is known as "Recognizance Ordinance" is adopted from Republic Act No. 10389, which is an act institutionalizing recognizance as a mode of granting the release of an indigent person in custody as an accused in a criminal case and for other purposes;

**WHEREFORE**, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Eleuterio C. Manaytay and Anna Cheryl N. Castro, it was




