

A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 2023-11 OF THE SANGGUNIANG BAYAN OF LUPON, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2016-03, ENTITLED: "AN ORDINANCE PROHIBITING THE MANUFACTURE, SALE, DISTRIBUTION, POSSESSION OR USE OF FIRECRACKERS OR PYROTECHNIC DEVICES AND SUCH OTHER SIMILAR DEVICES, AND THE EXPLODING OF FIRECRACKERS OR OTHER SIMILAR EXPLOSIVES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF LUPON, PROVINCE OF DAVAO ORIENTAL", SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, the Sangguniang Bayan of Lupon submitted Municipal Ordinance No. 2023-11to the Sangguniang Panlalawigan for an appropriate legislative action;

WHEREAS, the said Municipal Ordinance was enacted and approved by the Sangguniang Bayan of Lupon on its 68th Regular Session on November 6, 2023. The

Ordinance which is known as "No Firecracker Ordinance 2023" was passed in consonance with RA 7183 or An Act regulating the sale, manufacture, distribution and use of firecrackers and other pyrotechnic devices and Executive Order No. 28, dated June 20, 2017;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Eleuterio C. Manaytay and Anna Cheryl N. Castro, it was
