**A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 2023-12 OF THE SANGGUNIANG BAYAN OF LUPON, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE REGULATING THE USE AND OPERATION OF VIDEOKE/KARAOKE MACHINES AND OTHER SIMILAR AMPLIFIED AUDIO SOUND DEVICES, ALLOWING THE USE FROM 10:00 AM UNTIL 10:00 PM ONLY, PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES”, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.**

**WHEREAS**, the Sangguniang Bayan of Lupon submitted Municipal Ordinance No. 2023-12 to the Sangguniang Panlalawigan for an appropriate legislative action;

**WHEREAS**, the said Municipal Ordinance was enacted and approved by the Sangguniang Bayan of Lupon on its 68<sup>th</sup> Regular Session on November 6, 2023. The Ordinance which is known as “Videoke/Karaoke Machines Ordinance” was passed to protect the welfare of its citizens from excessive sound and vibration and inadequately

controlled noises which are serious hazards to public health and safety and is a source of annoyance to the local populace;

**WHEREFORE**, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Eleuterio C. Manaytay and Anna Cheryl N. Castro, it was

**RESOLVED**, as it is hereby resolved, **CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE NO. 2023-12 OF THE SANGGUNIANG BAYAN OF LUPON, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE REGULATING THE USE AND OPERATION OF VIDEOKE/KARAOKE MACHINES AND OTHER SIMILAR AMPLIFIED AUDIO SOUND DEVICES, ALLOWING THE USE FROM 10:00 AM UNTIL 10:00 PM ONLY, PROVIDING PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES"**, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO;


