A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE OF NO. 313-17-2023 OF THE SANGGUNIANG BAYAN OF SAN ISIDRO, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE IMPLEMENTING THE ZERO OPEN DEFECATION (ZOD) AND IMPOSING FINES AND PENALTIES FOR VIOLATIONS AND PROVIDING FUNDS THEREOF IN MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL", SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.
