A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE OF NO. 313-17-2023 OF THE SANGGUNIANG BAYAN OF SAN ISIDRO, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE IMPLEMENTING THE ZERO OPEN DEFECATION (ZOD) AND IMPOSING FINES AND PENALTIES FOR VIOLATIONS AND PROVIDING FUNDS THEREOF IN MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL”, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, in his letter, dated November 29, 2023, Mr. Melvin B. Lubitaña, Secretary to the Sangguniang Bayan of San Isidro, Davao Oriental, submitted Municipal Ordinance No. 313-17-2023 for legislative review of the Sangguniang Panlalawigan;

WHEREAS, the said ordinance requires every household within the territorial jurisdiction of the Municipality of San Isidro, to have a sanitary toilet in their respective homes to ensure proper disposal of human waste in order to prevent the occurrence of diseases caused by open defecation;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Eleuterio C. Manaytay and Anna Cheryl N. Castro, it was




