A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF MUNICIPAL ORDINANCE OF NO. 314-17-2023 OF THE SANGGUNIANG BAYAN OF SAN ISIDRO, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE PROMULGATING POLICIES AND MEASURES FOR THE PREVENTION AND CONTROL OF STI, HIV AND AIDS IN THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL PROVIDING PENALTIES FOR VIOLATIONS THEREOF, CREATING SAN ISIDRO STI, HIV AND AIDS COUNCIL (SISHAC) AND PROVIDING FOR ITS POWERS AND FUNCTIONS AND FOR OTHER PURPOSES”, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, the said Municipal Ordinance was enacted and approved by the Sangguniang Bayan of San Isidro on its 65th Regular Session on October 24, 2023;




