A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH DR. DENNIS B. PAHANG, DPBR, RELATIVE TO HIS SERVICES AS RADIOLOGIST OF DAVAO ORIENTAL PROVINCIAL HOSPITAL – MANAY (DOPH-MANAY), COVERING THE PERIOD FROM JANUARY 1, 2024 TO DECEMBER 31, 2024 WITH AN HONORARIUM OF PHP2,000.00 TO BE PAID ON A MONTHLY BASIS.

WHEREAS, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states that the Provincial Governor, as the chief executive of the provincial government, shall “*represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance*”;

WHEREAS, presented for consideration before the August Body is the letter-request from the Honorable Governor Niño Sotero L. Uy, Jr., dated November 29, 2023, requesting for the passage of a resolution authorizing him for the aforementioned subject matter, docketed as Communication No. 17-740-2023;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Eleuterio C. Manaytay and Anna Cheryl N. Castro, it was

RESOLVED, as it is hereby resolved, **AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH DR. DENNIS B. PAHANG, DPBR A DIPLOMATE IN RADIOLOGY WHICH IS A MAJOR REQUIREMENT TO SECURE THE LICENSE TO OPERATE AN X-RAY FACILITY IN DAVAO ORIENTAL PROVINCIAL HOSPITAL- MANAY (DOPH- MANAY);**




