RABAT, CITY MAYOR OF MATI, DAVAO ORIENTAL, RE: "CREATING THE CITY TRAINING MANAGEMENT TEAM (CTMT) FOR THE CONDUCT OF THE MANDATORY TRAININGS FOR SANGGUNIANG KABATAAN OFFICIALS AND LOCAL YOUTH DEVELOPMENT COUNCIL MEMBERS", CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE CITY MAYOR PURSUANT TO ARTICLE I, SECTION 455(b)(2)(iii) OF REPUBLIC ACT 7160.

WHEREAS, submitted for appropriate action before the August Body is Executive Order No. 99, series of 2023, transmitted by Ms. Ludivina T. Mas, Executive Assistant V of the City Mayor's Office of Mati, this province, embodied in Communication No. 17-744-2023, item number 21;

WHEREAS, Republic Act 10742 otherwise known as the (*Sangguniang Kabataan Reform Act of 2015*) as amended by Republic Act No. 11768, mandates the Sangguniang Kabataan official, whether elected or appointed, or any member of the

Local Youth Development Council to undergo a mandatory training programs before he or she can assume office to emphasize the role of the youth in nation-building and molding them to become a better citizens with the values of patriotism, nationalism and honor as a Filipino;

WHEREAS, in furtherance to the above cited provision, the City Mayor Michelle N. Rabat, issued the aforementioned Executive Order on the 3rd day of November 2023, pursuant to Article I, Section 455(b)(2)(iii) of Republic Act 7160;


