A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A DEED OF DONATION (DOD) WITH THE BUREAU OF THE TREASURY (BTr), REPRESENTED BY ITS OIC TREASURER OF THE PHILIPPINES, MS. SHARON P. ALMANZA, RELATIVE TO THE DONATION OF LOT CONTAINING AN AREA OF FIVE HUNDRED (500) SQUARE METERS, LOCATED AT THE GOVERNMENT CENTER, BARANGAY DAHICAN, CITY OF MATI, FOR THE PROPOSED CONSTRUCTION OF THE BTR – DAVAO ORIENTAL PROVINCIAL OFFICE.

WHEREAS, the Honorable Governor Niño Sotero L. Uy, Jr. has requested this august body for a passage of a Resolution with reference to SP Resolution No. 17-359-02-2023, duly approved by the late Governor Corazon N. Malanyaon, on March 10, 2023, entitled: *“A Resolution authorizing the Honorable Governor Corazon N. Malanyaon, for and in behalf of the Provincial Government of Davao Oriental, to enter into a Deed of Donation (DOD) with the Bureau of Treasury (BTr) XI, represented by its*

Regional Director, Ms. Maria Leticia R. Suribas, relative to the donation of lot containing an area of Five Hundred (500) square meters, located at the Government Center, Barangay Dahican, City of Mati, for the proposed construction of the BTr-Davao Oriental Provincial Office”;
