A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 555, SERIES OF 2023, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE REQUIRING/MANDATING ALL BUSINESS ESTABLISHMENTS SELLING/CATERING HALAL PRODUCTS OR SELLING HALAL FOODS TO PROVIDE SEPARATE STORAGE, DISPLAY SECTION, AND HALAL LANES EXCLUSIVELY FOR HALAL FOODS/NON-FOOD HALAL PRODUCTS AND BEVERAGES IN THEIR RESPECTIVE BUSINESSES, PROVIDING PENALTY FOR VIOLATION THEREOF AND FOR OTHER PURPOSES" CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD PURSUANT TO ARTICLE III, SECTION 458(a)(1) OF REPUBLIC ACT 7160.

WHEREAS, Section 16 of the Local Government Code of 1991, provides that: *"Every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare xxx;*

WHEREAS, presented for review before the August Body is City Ordinance No. 555, series of 2023, forwarded by Ms. Victoria P. Mara, Local Legislative Staff Officer V of Mati, Davao Oriental docketed as Communication No.17-747-2023;

WHEREAS, Section 2 of City Ordinance No. 555, series of 2023, states that: "*it is the purpose of this Ordinance to establish harmonious relationship between Christian and Muslims in the City of Mati by promoting, protecting, and respecting the Muslim religious beliefs, customs, and tradition especially in their concept of Halal to ensure that the foods they take and the products they use are spiritually pure and clean for consumption*";

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Stephen Paul L. Uy, Harold A. Montes, Anna Cheryl N. Castro, Shanine C. Lintogonan, Marietta D. Palmera, Joselito B. Villademoso, Rotchie M. Ravelo, and Eleuterio C. Manaytay, it was


