WHEREAS, Section 16 of the Local Government Code of 1991 states that, “Every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incident for its efficient and effective governance, and those which are essential to the promotion of the general welfare”.

WHEREAS, presented for review before the August Body is City Ordinance No. 578, series of 2023, forwarded by Mr. Juvy L. Mabini, Secretary to the Sangguniang Panlungsod, of Mati Davao Oriental, docketed as Communication No. 17-786-2023;

WHEREAS, the aforementioned Ordinance was enacted purposely to ensure adequate delivery of quality goods and services for the public welfare that provide a wide range of opportunities that will uplift the socio-economic well-being of its

constituents and further develop and implement modes of goods and services delivery that do not compete with but instead complement the private sector among others;
