RESOLVED, to declare Appropriation Ordinance No. 05-17-2023 of the Municipality of San Isidro, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160;

MOREOVER, the LGU is reminded of the relevant provisions under the Budget Operation Manual for Local Government Units issued under the Local Budget Circular No. 152, dated August 2, 2023, which provides that within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review.

RESOLVED FURTHER, to inform the Municipality of San Isidro, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of San Isidro, Davao Oriental, through the Municipal Mayor.


