A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 03-2023 OF THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 03-2023 of the Municipality of Lupon, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 03, involving an appropriation of **ELEVEN MILLION THREE HUNDRED SIXTY-SIX THOUSAND THREE HUNDRED THIRTY-NINE PESOS & 60/100 (P11,366,339.60)**, was submitted to this Sanggunian for review on December 6, 2023, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Anna Cheryl N. Castro, Harold A. Montes, Eleuterio C. Manaytay, Rotchie M. Ravelo, and Art Benjie C. Bulaong, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 03-2023 of the Municipality of Lupon, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. The Local Disaster Reduction and Management Fund shall conform with RA 10121 and its Implementing Rules and Regulations pursuant to NDDRMC-DBM-DILG Joint Memorandum Circular No. 2013-1, dated March 25, 2013, and other related issuances;
2. Lump sum appropriations in Special Purpose Appropriations / Other General Services / Capital Outlay, etc. shall be subject to Sections 305(b) and 335 of RA 7160, RA 9184 and its Revised IRR, and other existing pertinent laws, rules and regulations imposing restraints on government expenditures;
3. Fund appropriations for PPAs funded in this budget shall be in accordance with the approved CY 2023 Annual Investment Program (AIP) and/or Supplemental Annual Investment Program (SAIP) / Development Plan pursuant to Sections 287 and 305(i) of RA 7160; DILG MC No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2016 dated November 18, 2016.

RESOLVED FURTHER, to inform the Municipality of Lupon, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Lupon, Davao Oriental, through the Municipal Mayor.


