A RESOLUTION ENDORSING THE LETTER OF MAYOR MARIA ANGELICA T. GO, MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL, TO THE SANGGUNIANG BAYAN OF SAN ISIDRO FOR PROPER FILING OF PETITION PURSUANT TO PROCEDURES FOR SETTLING BOUNDARY DISPUTES AS PROVIDED BY ARTICLE 17(A) OF THE IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 7160.

WHEREAS, in her letter, the Municipal Mayor Maria Angelica T. Go of the Municipality of San Isidro requested for an urgent intervention of the Sangguniang Panlalawigan of the boundary dispute between the Municipality of San Isidro and Municipality of Governor Generoso. The latter municipality has an on-going construction of their welcome arch situated in Barangay La Union, Municipality of San Isidro;

WHEREAS, Section 118(b) of the Local Government Code of 1991 states that settlement of boundary dispute between and among LGU shall be referred to the Sangguniang Panlalawigan concerned;


