**A RESOLUTION RETURNING SB RESOLUTION NO. 2023-329 OF THE SANGGUNIANG BAYAN OF BANAYBANAY, DAVAO ORIENTAL, ENTITLED: “ENDORISING TO THE SANGGUNIANG PANLALAWIGAN THE ANCESTRAL DOMAIN MANAGEMENT OFFICE (ADMO) RESOLUTION NO. 2023-01, TO FURTHER TACKLE THE BOUNDARY CONFLICT BETWEEN THE MUNICIPALITY OF BANAYBANAY, DAVAO ORIENTAL AND THE MUNICIPALITY OF PANTUKAN, DAVAO DE ORO”, WITH NO ACTION, DUE TO LACK OF PERTINENT DOCUMENTS RELATIVE THE SETTLEMENT OF BOUNDARY DISPUTES PURSUANT TO ARTICLE 17 OF THE IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT 7160.**

**WHEREAS**, the Sangguniang Bayan of Banaybanay, thru a resolution, endorsed the Ancestral Domain Management Office (ADMO) Resolution No. 2023-01, requesting to further tackle the boundary conflict between the Municipality of Banaybanay, Davao Oriental and the Municipality of Pantukan, Davao De Oro.

**WHEREAS**, Section 118 (b) of the Local Government Code of 1991 states that settlement of boundary dispute between and among LGU shall be referred to the Sangguniang Panlalawigan concerned;



**WHEREAS**, Paragraph (c), Article 17, of the Implementing Rules and Regulations of RA 7160 provides for “Documents attached to petition — The petition shall be accompanied by: (1) Duly authenticated copy of the law or statute creating the LGU or any other document showing proof of creation of the LGU; (2) Provincial, city, municipal, or barangay map, as the case may be, duly certified by the LMB; (3) Technical description of the boundaries of the LGUs concerned; (4) Written certification of the provincial, city, or municipal assessor, as the case may be, as to territorial jurisdiction over the disputed area according to records in custody; (5) Written declarations or sworn statements of the people residing in the disputed area; and (6) Such other documents or information as may be required by the sanggunian hearing the dispute”.

**WHEREFORE**, on motion of SP Member Joselito B. Villademosa, duly and jointly seconded by SP Members Andy A. Monday, Jossone Michael G. Dayanghirang, Harold A. Montes, Art Benjie C. Bulaong, and Rotchie M. Ravelo, it was


