**A RESOLUTION APPRISING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., RELATIVE TO HIS REQUEST CONCERNING THE PASSAGE OF A RESOLUTION OR ORDINANCE DECLARING GOVERNOR CORAZON T. NUÑEZ MALANYAON (ICON-MOVABLE PROPERTY) AS HERITAGE/CULTURAL PROPERTY OF DAVAO ORIENTAL IN WHICH THE SANGUNIANG PANLALAWIGAN CANNOT ACT FORTHWITH CONSIDERING THAT THE SAME DOES NOT FALL UNDER THE CATEGORY LISTED AS CULTURAL PROPERTY OF THE COUNTRY, PURSUANT TO ARTICLE III, SECTIONS 4 AND 5 OF REPUBLIC ACT 10066.**

**WHEREAS**, presented for consideration before the August Body is a follow up letter from the Honorable Governor Niño Sotero L. Uy, Jr., dated January 22, 2024, requesting for the passage of a resolution or ordinance relative to the above-mentioned subject matter;

**WHEREAS**, the first letter-request of the Honorable Governor, dated September 8, 2023, relative thereto was received by the SPSSO on September 21, 2023, docketed as Communication No. 17-627-2023;

**WHEREAS**, the said request was referred to the Committee on Education, Arts, Culture Science and Technology for appropriate action;

**WHEREAS**, the aforesaid Committee conducted a Committee Meeting on November 8, 2023 and a Committee Hearing on February 13, 2024 to deliberate the same with the presence of the Provincial Culture and Arts Affairs Officer, representative from the Provincial Tourism Office and other concerned agencies to shed light on the matter;

**WHEREAS**, the Committee finds that the declaration of the foregoing does not fall under the category listed as the cultural property of the country as defined in Article III, Sections 4, and 5 of Republic Act 10066, otherwise known as "**National Cultural Heritage Act of 2009**";

**WHEREAS**, the Provincial Culture and Arts Affairs Office is enjoined by the Committee to explore further on its legal basis along with the icon of former Governors of this province who also deserve the same as a "Worthy Servant Leader" in conformity with the guidelines set forth by the Department of the Interior and Local Government (DILG) and the National Commission for Culture and the Arts (NCCA), Rules and Regulations Implementing Republic Act 10066, and other applicable laws relative thereto and provide this August Body a copy of the documents needed in aide of legislation;

**WHEREFORE**, on motion of SP Member Harold A. Montes, duly seconded by SP Members Daud V. Linsag, Rotchie M. Ravelo, Eleuterio C. Manaytay, and Andy A. Monday, it was;

**RESOLVED**, as it is hereby resolved, **APPRIISING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR. RELATIVE TO HIS REQUEST CONCERNING THE PASSAGE OF A RESOLUTION OR ORDINANCE DECLARING GOVERNOR CORAZON T. NUÑEZ MALANYAON (ICON-MOVABLE PROPERTY) AS HERITAGE/CULTURAL PROPERTY OF DAVAO ORIENTAL IN WHICH THE SANGUNIANG PANLALAWIGAN CANNOT ACT FORTHWITH CONSIDERING THAT THE SAME DOES NOT FALL UNDER THE CATEGORY LISTED AS CULTURAL PROPERTY OF THE COUNTRY, PURSUANT TO ARTICLE III, SECTION 4 AND 5 OF REPUBLIC ACT 10066.**


