WHEREAS, a request from the Honorable Governor Niño Sotero L. Uy, Jr., thru his letter, dated February 22, 2024 requesting the august body thru the Honorable Vice Governor for the passage of a resolution for the aforementioned subject matter;

WHEREAS, the above mentioned financial assistance is intended for the provision of immediate needs and concerns of the Province's constituents affected by the combined effects of the Northeast Monsoon and trough of Low Pressure Area, such as but not limited to the following forms of assistance:

1. Food
2. Medicines and other medical supplies
3. Cash assistance not exceeding P5,000.00 per household for immediate household need. Provided that the total cash assistance to households shall not exceed twenty percent (20%) of the total grant provided to the LGU;
4. Non-food items, as provided in the Deed of Donation.

WHEREAS, Section 465(b)(vi) of the Local Government Code of 1991 provides for the duty and function of the Provincial Governor to "*represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan pursuant to law or ordinance*";

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Harold A. Montes and Daud V. Linsag, it was

RESOLVED, as it is hereby resolved, **AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. 


