**A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 08, SERIES OF 2023, OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE ESTABLISHING THE ASSISTANCE PROGRAM FOR SECURING LAND TITLES OF ELIGIBLE RESIDENTS AND HOUSEHOLDS OF THE GOVERNOR GENEROSO TOWNSITE SUBDIVISION", SUBJECT TO EXISTING LAWS RULES AND REGULATIONS RELATIVE THERETO.**

**WHEREAS**, a letter, dated November 20, 2023 from the Honorable Mayor Juanito C. Inojales of Governor Generoso, Davao Oriental, addressed to the Honorable Vice Governor Nelson R. Dayanghirang, was received by the Sangguniang Panlalawigan Support Services Office on February 21, 2024, docketed as Communication No. 17-854-2024;

**WHEREAS**, Municipal Ordinance No. 08, series of 2023 was enacted by the Sangguniang Bayan on September 26, 2023, and the same was approved by the Municipal Mayor on October 5, 2023;

**WHEREAS**, the said municipal ordinance was considered invalid in part by the 17<sup>th</sup> Sangguniang Panlalawigan thru SP Resolution No. 17-706-11-2023, entitled: "A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 08, SERIES OF 2023, OF THE MUNICIPALITY OF GOVERNOR GENEROSO, INVALID IN PART, CONSIDERING THAT THE PROVISIONS UNDER SECTION 4 THEREOF IS NOT COMPLIANT WITH THE PROCEDURAL REQUIREMENT AS MANDATED UNDER SECTION 186 OF RA 7160" which was enacted on November 8, 2023;

**WHEREAS**, the Honorable Juanito C. Inojales has submitted the previously missing minutes and all related lacking documents stated in the resolution, ensuring a comprehensive and accurate representation of the public consultation process;

**WHEREFORE**, on motion of SP Member Anna Cheryl N. Castro, duly and jointly seconded by SP Members Rotchie M. Ravelo and Harold A. Montes, it was

**RESOLVED**, as it is hereby resolved, **CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 08, SERIES OF 2023, OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE ESTABLISHING THE ASSISTANCE PROGRAM FOR SECURING LAND TITLES OF ELIGIBLE RESIDENTS AND HOUSEHOLDS OF THE GOVERNOR GENEROSO TOWNSITE SUBDIVISION"**, SUBJECT TO EXISTING LAWS RULES AND REGULATIONS RELATIVE THERETO;
