**A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 317-17-2024 OF THE SANGGUNIANG BAYAN OF SAN ISIDRO, DAVAO ORIENTAL, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, SUBJECT TO SECTION 123 OF RA 7653, AS IMPLEMENTED BY THE BANGKO SENTRAL NG PILIPINAS CIRCULAR NO. 402, AND OTHER LAWS AND REGULATIONS PERTINENT THERETO.**

**WHEREAS**, submitted for review before this August Body is Municipal Ordinance No. 317-17-2024, entitled: *“AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR MARIA ANGELICA T. GO TO REPRESENT THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL TO ENTER INTO A CONTRACT OF LOAN WITH DEVELOPMENT BANK OF THE PHILIPPINES (DBP) IN THE PRINCIPAL AMOUNT OF ONE HUNDRED FIFTEEN MILLION PESOS (PHP115,000,000.00) FOR THE PURPOSES STATED HEREIN AND TO SIGN THE LOAN AGREEMENT, DEED OF ASSIGNMENT, THE PROMISSORY NOTE AND OTHER DOCUMENTS RELATED THERETO”;*

**WHEREAS**, said Municipal Ordinance was enacted by the Sangguniang Bayan on February 6, 2024, and the same was approved by the Municipal Mayor on February 9, 2024;

**WHEREAS**, Section 296(a) and Article 394(a) of RA 7160 and its IRR, respectively, states that: *“the LGU may create indebtedness, and avail of credit facilities to finance local infrastructure and other socio-economic development projects in accordance with the approved local development plan and public investment program”*;

**WHEREFORE**, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Daud V. Linsag, Andy A. Monday, and Anna Cheryl N. Castro, it was




