A RESOLUTION RETURNING TO THE SANGGUNIANG BAYAN OF SAN ISIDRO, DAVAO ORIENTAL, THROUGH THE MUNICIPAL MAYOR, THE APPROPRIATION ORDINANCE NO. 01-17-2024, WITHOUT ACTION, PENDING CLARIFICATION ON THE FINDINGS STATED HEREIN, AND FOR THEIR APPROPRIATE ACTION THEREON.

WHEREAS, submitted for review before this August Body is the Appropriation Ordinance No. 01-17-2024, authorizing the Supplemental Budget No. 01 of the Municipality of San Isidro, involving the appropriation of Two Million Two Hundred Thirty Thousand Two Hundred Eighty-Nine Pesos & 91/100 (₱2,230,289.91);

WHEREAS, Appropriation Ordinance No. 01-17-2024 entitled: "AN APPROPRIATION ORDINANCE AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 01, C.Y. 2024 AMOUNTING TO TWO MILLION TWO HUNDRED THIRTY THOUSAND TWO HUNDRED EIGHTY-NINE PESOS & NINETY-ONE CENTS (PHP2,230,289.91)

FOR THE OPERATION OF THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL
FROM JANUARY 1, 2023 TO DECEMBER 31, 2023”;

WHEREAS, the said Appropriation Ordinance was enacted by the Sangguniang Bayan on January 17, 2024, approved by the Municipal Mayor on January 22, 2024, and was only transmitted for review on February 16, 2024;

WHEREAS, pursuant to Section 327 of RA 7160 which provides for the powers of the Sangguniang Panlalawigan to review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities, this august body finds the need for clarification on the underscored premise, hence, returning the subject AO without action;

WHEREAS, it is understood that, pursuant to Section 327 of RA 7160, the 90-days reglementary period of this Sangguniang Panlalawigan to review and act on the same will end on May 16, 2024;

WHEREAS, compliance with all existing laws, rules and regulations shall be the responsibility of the implementing local government unit;

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Daud V. Linsag, Andy A. Monday, and Anna Cheryl N. Castro, it was

RESOLVED, as it is hereby resolved, **RETURNING TO THE SANGGUNIANG BAYAN OF SAN ISIDRO, DAVAO ORIENTAL, THROUGH THE MUNICIPAL MAYOR, THE APPROPRIATION ORDINANCE NO. 01-17-2024, WITHOUT ACTION, PENDING CLARIFICATION ON THE FINDINGS STATED HEREIN, AND FOR THEIR APPROPRIATE ACTION THEREON;**




