**A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2024-01 OF THE SANGGUNIANG BAYAN OF BANAYBANAY, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE COMMEMORATING THE ANNUAL INDIGENOUS PEOPLES’ MONTH EVERY OCTOBER IN THE MUNICIPALITY OF BANAYBANAY AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(A)(1) OF REPUBLIC ACT 7160.**

**WHEREAS**, submitted for review before the August Body is Municipal Ordinance No. 2024-01 of the Sangguniang Bayan of Banaybanay, Davao Oriental, this province;

**WHEREAS**, the said Ordinance was enacted by the Sangguniang Bayan of Banaybanay on the 23<sup>rd</sup> day of January, 2024, in adherence to the above cited provisions;

**WHEREAS**, pursuant to Section 16 of the Local Government Code of 1991, which states that: *“Every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare xxx”*;

**WHEREAS**, Section 22, Article II of the 1987 Philippine Constitutions further provides that: *“The State recognizes and promotes the rights of indigenous cultural communities within the framework of national unity and development”*;

**WHEREAS**, Presidential Proclamation No. 1906, series of 2009, as amended by the Presidential Proclamation No. 1906-A, series of 2009, declared the month of October as the Month of Indigenous Peoples (IP) to revel the cultural wealth and heritage bestowed upon Filipinos;

**WHEREFORE**, on motion of SP Member Eleuterio C. Manaytay, duly and jointly seconded by SP Members Anna Cheryl N. Castro, Harold A. Montes, Rotchie M. Ravelo, and Daud V. Linsag, it was


