A RESOLUTION CONFIRMING THE VALIDITY OF THE CITY ORDINANCE NO. 590, SERIES OF 2024, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE CHANGING THE NAME OF MATIAO CENTRAL ELEMENTARY SCHOOL TO PATERNO MADANLO MATIAO CENTRAL ELEMENTARY SCHOOL", SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, Sections 1 and 2(1) of Article XIV of the Philippine Constitution provides that: "the State shall protect and promote the right of all citizens to quality education at all levels, shall take appropriate steps to make such education accessible to all and establish, maintain and support a complete, adequate, and integrated system of education relevant to the needs of the people and society";

WHEREAS, Section 13(e) of Republic Act 7160, provides that: "A change of name of a public school shall be made only upon the recommendation of the local school board concerned";

WHEREAS, presented for review before the August Body is City Ordinance No. 590, series 2024, forwarded by Mr. Juvy L. Mabini, Secretary to the Sangguniang Panlungsod of Mati, Davao Oriental, docketed as Communication No. 17-845-2024, item number 3;

WHEREAS, the foregoing ordinance was enacted by the Sangguniang Panlungsod of Mati on the 6th day of February, 2024, upon the recommendation/request of Local School Board and the Barangay Council of Matiao, City of Mati, Davao Oriental, requesting to change the same;

WHEREAS, the aforementioned school is located at Barangay Matiao, City of Mati, Davao Oriental;

WHEREFORE, on motion of SP Member Harold A. Montes, duly and jointly seconded by SP Members Rotchie M. Ravelo and Daud V. Linsag, it was
