WHEREAS, in Section 80(b) of the RA 7160, stated: *“There shall be established in every province, city or municipality a personnel selection board to assist the local chief executive in the judicious and objective selection of personnel for employment as well as for promotion, and in the formulation of such policies as would contribute to employee welfare”*;

WHEREFORE, on motion of SP Member Harold A. Montes, duly and jointly seconded by SP Members Daud V. Linsag, Eleuterio C. Manaytay, Rotchie M. Ravelo, Anna Cheryl M. Castro, and Art Benjie C. Bulaong, it was


