**A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF CITY ORDINANCE NO. 575, SERIES OF 2024, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE INSTITUTIONALIZING THE USE OF EMERGENCY CITY WIDE SIREN ALERT SYSTEM, PROVIDING MECHANISMS FOR THE IMPLEMENTATION THEREOF AND FOR OTHER PURPOSES”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD PURSUANT TO ARTICLE III, SECTION 458(A)(1) OF REPUBLIC ACT 7160.**

**WHEREAS**, in his letter, dated February 15, 2024, Mr. Juvy L. Mabini, J.D., Secretary to the Sangguniang Panlungsod of Mati, Davao Oriental, submitted the above City Ordinance for legislative review of the Sangguniang Panlalawigan, docketed as Communication No. 17-845-2024;



**WHEREAS**, the purpose of this Ordinance is mainly to establish an early warning system by institutionalizing its city-wide siren alert system as an early warning for potential disastrous events that might hit the City of Mati. Its implementation is essential to prepare and respond to first stages of disaster management;


