**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 96, SERIES OF 2023, OF THE MUNICIPALITY OF BOSTON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY.**

**WHEREAS**, Appropriation Ordinance No. 96, series of 2023, of the Municipality of Boston, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 3, involving an appropriation of **FIVE MILLION THREE HUNDRED EIGHTY-SEVEN THOUSAND PESOS (P5,387,000.00)**, was submitted to this Sanggunian for review on December 11, 2023, pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

**RESOLVED**, to declare Appropriation Ordinance No. 96, series of 2023, of the Municipality of Boston, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160;

**MOREOVER**, the LGU is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under the Local Budget Circular No. 152, dated August 2, 2023, which provides that: *“Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review”*;

**RESOLVED FURTHER**, to inform the Municipality of Boston, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Boston, Davao Oriental, through the Municipal Mayor.


