**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2023-20-03 OF THE MUNICIPALITY OF MANAY, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 2023-20-03 of the Municipality of Manay, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 02, involving an appropriation of **NINE MILLION THREE HUNDRED SIXTEEN THOUSAND THREE HUNDRED SIX PESOS (P9,316,306.00)**, was submitted to this Sanggunian for review on December 28, 2023, pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;



**WHEREFORE**, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Daud V. Linsag, Anna Cheryl N. Castro, Art Benjie C. Bulaong, and Harold A. Montes, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 2023-20-03 of the Municipality of Manay, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. Fund appropriation for Other Personnel Benefits shall be supported with a specific guidelines issued by the Department of Budget and Management and/or other authorized agencies;
2. Lump sum appropriations in Other General Services, Other Maintenance and Operating Expenses shall be subject to Sections 305(b) and 335 of RA 7160; RA 9184 (Government Procurement Reform Act) and its IRR; and other existing pertinent laws, rules and regulations imposing restraints on government expenditures.

**MOREOVER**, the LGU is reminded to indicate the Date of Approval of the Appropriation Ordinance by the Local Chief Executive, the same being vital in determining the date of which is required pursuant to the provisions under the Budget Operation Manual for Local Government Units issued under the Local Budget Circular No. 152, dated August 2, 2023, which provides that within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review;

**RESOLVED FURTHER**, to inform the Municipality of Manay, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Manay, Davao Oriental, through the Municipal Mayor.
