A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 08-17-2023 OF THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 08-17-2023 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 06, involving an appropriation of NINE MILLION FOUR HUNDRED FIVE THOUSAND THREE HUNDRED SEVENTY-SEVEN PESOS & 86/100 (₱9,405,377.86), was submitted to this Sanggunian for review on January 5, 2024, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 08-17-2023 of the Municipality of San Isidro, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- 1. The grant of Productivity Enhancement Incentive (PEI) shall be in accordance with DBM Budget Circular No. 2017-4, dated December 4, 2017;
- 2. The grant of Collective Negotiation Agreement (CNA) and Service Recognition Incentive (SRI) to the government officials and employees shall be in accordance with DBM Budget Circular No. 2023-1, dated November 10, 2023 and BC No. 2023-2, dated December 13, 2023, respectively;
- 3. The grant of Performance Based Bonus (PBB) to the government officials and employees shall be in accordance with DBM Memorandum Circular No. 2022-1, dated March 24, 2022.

MOREOVER, the LGU is reminded of the relevant provisions under the Budget Operation Manual for Local Government Units issued under the Local Budget Circular No. 152, dated August 2, 2023, which provides that within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review.

RESOLVED FURTHER, to inform the Municipality of San Isidro, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of San Isidro, Davao Oriental, through the Municipal Mayor.
