

A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2023-09 OF THE MUNICIPALITY OF BANAYBANAY, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 2023-09 of the Municipality of Banaybanay, Davao Oriental, authorizing its CY 2023 General Fund Supplemental Budget No. 07, involving an appropriation of **NINE MILLION ONE HUNDRED SIXTEEN** THOUSAND ONE HUNDRED ELEVEN PESOS (₱9,116,111.00), was submitted to this Sanggunian for review on January 4, 2024, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2023-09 of the Municipality of Banaybanay, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- 1. The grant of Service Recognition Incentive (SRI) to the government officials and employees shall be in accordance with DBM Budget Circular No. 2023-2, dated December 13, 2023;
- 2. Fund appropriations for PPAs funded in this budget shall be in accordance with the approved CY 2023 Annual Investment Program (AIP) and/or Supplemental Annual Investment Program (SAIP) / Development Plan pursuant to Sections 287 and 305(i) of RA 7160, DILG MC No. 2004-130, dated October 1, 2004, DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2016, dated November 18, 2016.

MOREOVER, the LGU is reminded of the relevant provision under the Budget Operation Manual for Local Government Units issued under the Local Budget Circular No. 152, dated August 2, 2023, which provides that: "Within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review".

RESOLVED FURTHER, to inform the Municipality of Banaybanay, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Banaybanay, Davao Oriental through the Municipal Mayor.
