# RESOLUTION NO. 17-881-03-2024

A RESOLUTION RETURNING TO THE SANGGUNIANG PANLUNGSOD OF CITY OF MATI, DAVAO ORIENTAL, THROUGH THE CITY MAYOR, THE APPROPRIATION ORDINANCE NO. 07, SERIES OF 2023, WITHOUT ACTION, PENDING CLARIFICATION ON THE FINDINGS STATED HEREIN, AND FOR THEIR APPROPRIATE ACTION THEREON.

WHEREAS, submitted for review before this August Body is the Appropriation Ordinance No. 07, series of 2023, authorizing the Supplemental Budget No. 06 of the City of Mati, Davao Oriental, involving the appropriation of One Hundred Fifteen Million Three Hundred Seventy-Six Thousand Four Hundred Fifty-Seven Pesos & 72/100 (₱115,376,457.72); Puplaza

WHEREAS, said AO was enacted by the Sangguniang Panlungsod on November 28, 2023, <u>approved by the City Mayor on January 4 2024</u>, and the same was transmitted for review on January 4 2024;

**WHEREAS**, Section 353 provides that the official fiscal year of LGUs shall be the period beginning with the first (1<sup>st</sup>)day of January and ending with the thirty-first (31<sup>st</sup>) day of December of the same year;

WHEREAS, any supplemental budget should be authorized by an Appropriation Ordinance within the fiscal year covered by the annual budget that it supplements/changes. The same shall take effect upon its approval or on the date fixed therein, pursuant to Section 320 and Article 416(b) of the Local Government Code of 1991 and its IRR, respectively;

WHEREAS, pursuant to Section 327 of RA 7160 which provides for the powers of the Sangguniang Panlalawigan to review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities, this august body finds the need for clarification on the underscored premise, hence, returning the subject AO without action;

WHEREAS, it is understood that, pursuant to Section 327 of RA 7160, the 90-day reglementary period of this Sangguniang Panlalawigan to review and act on the same will end on April 4, 2024;

**WHEREAS**, compliance with all existing laws, rules and regulations shall be the responsibility of the implementing local government unit;

**WHEREFORE,** on motion of SP Member Andy A, Monday, duly and jointly seconded by SP Members Art Benjie A. Bulaong and Daud V. Linsag, it was

RESOLVED, as it is hereby resolved, RETURNING TO THE SANGGUNIANG PANLUNGSOD OF CITY OF MATI, DAVAO ORIENTAL, THROUGH THE CITY MAYOR, THE APPROPRIATION ORDINANCE NO. 07, SERIES OF 2023, WITHOUT ACTION, PENDING CLARIFICATION ON THE FINDINGS STATED HEREIN, AND FOR THEIR APPROPRIATE ACTION THEREON;
