## EXECUTIVE ORDER NO. 04 Series of 2023

DESIGNATING MR. ROD JOHN D. PANDILI AS FOCAL PERSON/LIAISON OFFICER IN THE IMPLEMENTATION OF PEACE-BUILDING ACTIVITIES IN SUPPORT OF THE LOCALIZED PEACE ENGAGEMENT WORK PURSUANT TO EXECUTIVE ORDER NO. 70, S. 2018

WHEREAS, on 04 December 2018, President Rodrigo R. Duterte signed Executive Order (EO) No. 70, s. 2018, entitled "Institutionalizing the Whole-of-Nation Approach in Attaining Inclusive and Sustainable Peace, Creating a National Task Force to End Local Communist Armed Conflict, and Directing the Adoption of a National Peace Framework";

WHEREAS, EO No. 70 s. 2018 aims to provide an efficient mechanism and structure for the implementation of the Whole-of-Nation approach in addressing the root causes of insurgencies, internal disturbances and tensions, and other armed conflicts and threats by prioritizing and harmonizing the delivery of basic services and social development packages by the government, facilitating societal inclusivity, and ensuring the active participation of all sectors of society in pursuit of the country's peace agenda;

WHEREAS, Joint Memorandum Circular (MC) No. 01, s. 2019 of the National Task Force to End Local Communist Armed Conflict (NTF-ELCAC) provides that the LGU is the main implementer of the programs, provider of basic services and initiator of projects and activities (PPAs) in the local level;

WHEREAS, as a local government unit (LGU), the Provincial Government of Davao Oriental recognizes the importance of sustaining the implementation of EO No. 70 by the PTF-ELCAC to fulfill its mandate of promoting the welfare of its constituency, providing basic services, upholding the rule of law and managing the peace and security situation of the province;

WHEREAS, Provincial Peace and Order Council issued Resolution No. 1, s. 2022 declaring the Province of Davao Oriental as "Insurgency-Free" or "Stable Internal Peace and Security-Province" as per Revised Joint Implementing Rules and Regulations to Executive Order 546 in relation to Executive Order 110 as of September 19, 2022;

WHEREAS, former Gov. Corazon Malanyaon issued EO No. 9, s. 2023, which reconstituted the Provincial Task Force to End Local Communist Armed Conflict (PTF-ELCAC); creating a PTC ELCAC Office under the Provincial Governor's Office, Designating its focal person and adopting Peace Framework in the Province of Davao Oriental, and providing funds thereof;

WHEREAS, to strengthen the partnership and collaboration of EO 70 stakeholders, particularly between and among the PLGU, Armed Forces of the Philippines (AFP) and Philippine National Police (PNP), in the implementation of projects, programs and activities (PPAs) on peace and order, capacity development, constituency building, among others,

the Provincial Government deems it necessary to designate a suitable individual for the purpose;

NOW, THEREFORE, I, NIÑO SOTERO L. UY, by virtue of the powers vested upon me by law as Governor of the Province of Davao Oriental, do hereby order the designation of Mr. Rod John D. Pandili, Senior Administrative Assistant II of the Province Budget Office this Province, as Focal Person/Liaison Officer in the implementation of ELCAC and peace building-related PPAs.

As such, he shall exercise such powers and carry out the duties, responsibilities and functions, as follows:

- To facilitate coordination/ collaboration and conveyance of national agencies, private partners, and peace and development stakeholders;
- b. Act as liaison, ensure regular communication and better coordination in the conduct of activities among the twelve (12) different PTF ELCAC Clusters: Local Government and Empowerment, International Engagement, Legal Cooperation, Strategic Communication, Basic Services, Poverty Reduction, Livelihood & Empowerment, Infrastructure and Resource Management, Situation and Knowledge Management, Local Peace Engagement, E-Clip and Amnesty, and Sectoral Unification, Capability Building and Empowerment;
- Attend/Participate in PTF-ELCAC meetings and activities and articulate the policy thrusts and direction of this administration towards the attainment of inclusive and sustainable peace;
- d. If necessary, visit the office and/or require the presence of a public officer or private individual or party for a meeting/conference to discuss issues, concerns and matters affecting efforts of the Provincial Government relative to peace, security and public safety;
- e. Recommend transformation plan for the Province and peace-related PPA funding requests and proposals for approval/disapproval of the Governor, after due consultation with the proponents;
- f. Consult, confer, and liaise with officers of the Philippine uniformed services (PNP and AFP-PA/PCG) relative to their conduct of peace, security and safety operations or activities within the territorial jurisdiction of the Province of Davao Oriental; and
- g. Perform such other tasks and functions as the Governor may direct.

This Executive Order takes effect immediately upon its approval.
