PROVINCIAL ORDINANCE NO. 17-32-02-2024

AN ORDINANCE PRESCRIBING THE RULES AND REGULATIONS IN THE IMPLEMENTATION OF THE ANNUAL PROVINCIAL AID TO THE BARANGAYS IN THE AMOUNT OF THREE HUNDRED THOUSAND PESOS (P300,000.00) ONLY AS APPROVED UNDER THE ANNUAL BUDGET CONSISTENT TO RELEVANT BUDGETING, ACCOUNTING AND AUDITING PROCEDURES SET BY LAW.

WHEREAS, the Local Government Code of 1991 (RA 7160) accords every local government unit the power and authority to promote the general welfare of its constituents, promote health and safety, encourage and support the development appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, there is the need to improve the various needs/basic services of the barangays within the province of Davao Oriental; Luplaza WHEREAS, Section 324(c) of RA 7160, otherwise known as the Local Government Code of 1991, provides that "In the case of provinces, cities, and municipalities, aid to component barangays shall be provided in amounts of not less than One thousand pesos (P1,000.00) per barangay; "

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Harold A. Montes, Anna Cheryl N. Castro, Art Benjie C. Bulaong, and it was

- Section 1. Short Title. This Ordinance shall be known as the "Provincial Aid to the Barangays".
- **Section 2. Declaration of Policy. -** The purpose of this ordinance is to further help the progress and augment the various needs of the barangay and shall apply to all projects, programs, and activities funded by the provincial local government unit for the purpose of providing Barangay Aid.
- **Section 3. Definition of Terms.** As used in this Ordinance, the following terms shall mean:
 - a) Barangay historically referred to as a barrio is the smallest administrative division in the Philippines.
 - b) Aid tangible means of assistance (such as money or supplies) government aid.
 - c) Provincial Aid refers to the aid to barangays amounting to Three Hundred Thousand Pesos (P300,000.00) only as approved in the Annual Appropriation Ordinance.
 - d) Budgeting is the process of allocating finite resources to the prioritized needs of an organization.
 - e) Accounting is the process of keeping track with all financial transactions within a business such as any money coming in and money going out.
 - f) Auditing- is the most common way of actually looking at the financial statements alongside other accounting data of a business or an organization.

Section 4. General Provisions.

- 4.1 Financial Assistance Every barangay shall be appropriated an amount to Three Hundred Thousand Pesos only (P300,000.00) as financial assistance.
- 4.2 Documentary Requirement The Program of Work or Activity Design of the project shall be submitted One (1) month before its use. This project documents shall specify the lists of programs/projects/activities and its corresponding budget requirements. The documents shall be submitted to Provincial Governor for its approval.
- 4.3 Manner of Release The release of the Barangay Aid shall be done through transfer of funds provided that documentary requirements are complied with.
- 4.4 Accomplishment Report The barangay shall submit the accomplishment with photo documentation or liquidation report to the Provincial Governor within thirty (30) days upon completion of the program/project/activities as submitted.

- **Section 5. Appropriations.** The Provincial Local Government Unit shall appropriate a total of Three Hundred Thousand Pesos (P 300,000.00) only for each barangay.
- **Section 6. Repealing Clause.** All ordinances and executive issuances of the Provincial Local Government Unit contrary to or inconsistent with this Ordinance are hereby repealed or modified.
- **Section 7. Separability Clause.** If any part of provision of this Ordinance is declared unconstitutional or invalid, the same shall not affect the validity and effectivity of the other parts or provision hereof.
- **Section 8. Penalty Clause.** This Ordinance shall follow existing laws, rules and regulations of the Department of Budget and Management, Commission on Audit and Ombudsman.
- **Section 9. Effectivity Clause.** This Ordinance shall take effect fifteen (15) days after its publication in a newspaper of local or general circulation or posting in at least two (2) conspicuous places in the Province of Davao Oriental.
