A RESOLUTION RESPECTFULLY REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT THROUGH ITS REGIONAL DIRECTOR GARY R. MARTEL, FOR THE REVIEW STATUS OF THE APPROVED FISCAL YEAR 2024 GENERAL FUND ANNUAL BUDGET OF THE PROVINCE OF DAVAO ORIENTAL, SUBMITTED TO THAT OFFICE ON FEBRUARY 29, 2024.

WHEREAS, Section 326 of RA 7160 mandates the Department of Budget and Management to review ordinances authorizing the annual or supplemental appropriations of provinces, highly-urbanized cities, independent component cities, and municipalities within the Metropolitan Manila Area in accordance with the immediately succeeding section;

WHEREAS, the Sangguniang Panlalawigan of Davao Oriental enacted the Appropriation Ordinance No. 17-11-01-2024 authorizing the FY 2024 General Fund Annual Budget of the Province on January 10, 2024;

WHEREAS, however, on February 12, 2024, the Honorable Governor Niño Sotero L. Uy, Jr., vetoed the entire appropriation ordinance. Subsequently, on February 21, 2024, the Sangguniang Panlalawigan exercised its authority and successfully overrode the Governor's veto, pursuant to Section 55(c) of RA 7160;

WHEREAS, this august body unanimously agreed to be apprised on the review status of the said Appropriation Ordinance submitted to the Department of Budget and Management on February 29, 2024, for its information and guidance;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Harold A. Montes, Anna Cheryl N. Castro, Eleuterio C. Manaytay, and Daud V. Linsag, it was
